Short description of the content of the EDI agreement

This document has no legal effect and should solely be seen as a help for non-Swedish-speaking people to understand the content of the Ediel Agreement. Svenska kraftnät takes no responsibility for any inaccuracies in this document. Only what is stated in the agreement applies and if a complete translation is desired, it is the responsibility of each individual actor.

To participate in the Swedish electricity and / or gas market, you need to be connected to the Swedish Ediel system. This is done by entering into an agreement with Svenska kraftnät. By signing the agreement, you will receive an Ediel identification code that will be used to identify yourself in the electronic communication with other market participants.

What is Ediel?

Ediel is the electricity and gas industry's EDI system (Electronic Data Interchange) used for electronic information exchange between market participants active in the Swedish energy market. This system handles information such as reporting of measured values and other market information which does not take place in real time. Ediel is based on international standards that the industry jointly develops further based on new requirements. The system operator, network owners, electricity / gas suppliers and balance responsibles are obliged to use Svenska kraftnät's EDI standard for their communication with other market participants. To be able to use Ediel, an EDI agreement is needed, which is signed together with Svenska kraftnät.

By signing an EDI agreement, also known as the Ediel agreement, the parties have agreed that the exchange of information with EDI messages within the framework of the EDI standard developed by Svenska kraftnät shall comply with the terms and conditions set out in this agreement and from the other applicable appendices and by Svenska kraftnät's applicable user guides and Ediel user guides.

Content of the EDI Agreement

The main agreement

The main agreement begins with you as the actor signing the agreement, you should start to fill in the company's full name, address and organisation number (VAT number).

Chapter 1 Definitions

This chapter describes the definitions that recur in the agreement.

Chapter 2 Agents

As an "Edielaktör" in Sweden, it is possible to use service providers. However, these providers must be approved by Svenska kraftnät. When using a representative, it is also necessary to clearly define what the representative is responsible for. The provider used must also have entered into an Ediel agreement with Svenska kraftnät.

Chapter 3 Use etc. of Svenska kraftnät's EDI standard

This chapter describes the requirements for the EDI user. It is important for the user that they have information and communication systems that can handle the requirements described in the user guides from Svenska kraftnät. The systems must also be tested and approved according to these requirements. The user has two weeks to ensure that their systems are approved. If the user changes systems or there is a new user guide, the user must once again ensure that they are approved. The user must ensure that it is approved no later than two weeks after the agreement has taken effect or two weeks after the new format or format version has been introduced.

In connection with the agreement being signed, Svenska kraftnät assigns the user an Edielid.

Chapter 4 Exchanging EDI Messages

If for any reason it is not possible to exchange EDI messages, the user should notify other affected users. A recipient of EDI messages is obliged to process them without delay and if you receive a message that has been sent incorrectly, the sender must be notified.

Chapter 5 Log

Each user is required to have a log of sent and received messages. This must be available in the event of any disputes.

Chapter 6 Receipt confirmations and Receipts

Receipt confirmations and receipts must be handled in accordance with Svenska kraftnät's Ediel user guides.



Chapter 7 The binding effect of the EDI Message

In general, an EDI message is considered binding when it has been logged by both sender and recipient.

Chapter 8 Security of the EDI system and EDI messages

This chapter describes the rules on the safety of the EDI system. It is not permitted to use this system for anything other than Ediel. The user is also obliged to ensure that no unauthorized person can use the system.

Chapter 9 The Ediel® brand

The user may not use the term Ediel® so that it in any way infringes on Svenska kraftnät's brand.

Chapter 10 Contact person

The user is obliged to have contact persons appointed in accordance with the rules contained in Svenska kraftnät's user guides.

Chapter 11 Confidentiality

Information obtained through Ediel must be handled with confidentiality. However, this does not apply to information that is considered public dooomain.

Chapter 12 Responsibility

This chapter regulates the responsibility of Svenska kraftnät and other parties in the use of Ediel.

Chapter 13 Fines

Svenska kraftnät has the right to charge a fine unless an EDI user is approved according to current regulation. The fine is paid for each commenced week that the EDI user is not approved and the amount is calculated on the previous 12-month period's EDI fee. However, it is at least SEK 3,000 for each week started.

14 Contract period

After the EDI agreement has been signed, it is valid until further notice. It can only be terminated at the end of the calendar year with a 6-month notice period. If the agreement is changed, however, it can be terminated with one month's notice. In the event of a breach of contract, the agreement can be terminated at shorter notice.



15 Cost for using Ediel

Svenska kraftnät charges a fee for using Ediel. More about this can be found in Appendix 1.

16 Changes and additions to the agreement

Svenska kraftnät has the right to change the terms of the agreement after dialogue with representatives from the industry. This must be done with 6 months' notice. In the event of any regulatory amendments, this period may be shortened.

17 Transfer and assignment

The Ediel user does not have the right to transfer the agreement without Svenska kraftnät's consent. This also applies to the use of the Edi system.

18 Dispute

Disputes arising from the EDI agreement shall be handled by the Stockholm District Court.

Appendix 1. Fees and invoicing

The EDI system and related operations at Svenska kraftnät are financed with fees charged by all EDI users. All EDI users must be registered on the Swedish Ediel portal and will be charged a fixed fee per EDI user - a portal fee. This applies to both electricity and gas players. In addition to the fixed fee, network owners and balance responsibles pay a variable fee based on consumption. Invoicing occurs semi-annually.

Svenska kraftnät has the right to issue fines to those companies that are not approved in accordance with current regulations.
